Brothers and Sisters,

I hope this letter finds you well and that you are looking forward to this year's summer months. As work continues to pick up, I anticipate that we will continue to see a growth in our hours across the board. I am pleased to report that hours have increased compared to this time last year. We currently have nearly 79% growth in the residential market and just under 3% in the CBA. This represents nearly 8% growth overall. I fully expect these trends to continue, as we move forward to seeing more of our members back to work as soon as possible.

In addition to the growth in work hours, we were also able to save an additional \$2 million dollars in the Target Fund via the re-negotiation of contracts. This cost-saving commitment will ensure the continued health of the fund and represents our due diligence to ensure The Target Fund is strategically used to benefit our members. I and your elected officers will continue to be constant stewards of the fund, and judiciously use it for its intended purpose... to put the men / women of Local 638 to work without being compromised by the current contractors who hire them.

The New York State legislative session recently concluded on June 6th. Local 638, once again, was an active participant in raising awareness of our issues with your local elected officials. I spent multiple weeks in Albany this year meeting with politicians negotiating the labor standards that are attached to a new tax incentive for affordable housing. An initial proposal that would have required only a \$40 per hour wage rate, was negotiated up to over \$72 per hour on eligible projects. This will allow us to be competitive on residential projects across Manhattan, Queens and Brooklyn. We worked hard to send the message to Albany that New York's housing affordability crisis can only be solved with the use of skilled, union labor men & women building highquality projects with regards to the housing market.

Additional legislative 'wins' came from the passage of a bill requiring all prevailing wage projects in the state to submit their payroll to a central, electronic database. This will make it easier for your Organizers and Business Agents to access certified payroll and catch the bad "actors" immediately when they are committing wage theft and fraud.

A bill requiring prevailing wage rates on any project using public money to clean up polluted 'Brownfield' sites was also passed. New York City alone is the home of over 3,000 Brownfield sites, and there are nearly 4,500 sites across Long Island. Any cleanup and development of these sites will now be subject to the prevailing wage rate of New York City / Long Island.

We also secured a requirement for a project labor agreement on all SUNY construction projects over \$10 million, completing a multiyear campaign to make sure public universities use union labor.

Finally, we passed a bill fast-tracking the licensing of the three downstate casinos that will inevitably be built in New York City and Long Island, ensuring that the public review process will be completed by 2025, so that shovels will go in the ground as quickly as possible wherever these projects are ultimately built.

I am happy to relate this quarter's developments, both as it relates to our current state of work and the opportunities we look forward to in the near future. In closing, I would like to thank your dedicated elected officers, who work hard to ensure the health and well being of our union, Steamfitters Local 638.

Dear Brothers and Sisters of 638

As I sit and write this newsletter and reflect on the past 12 months since your Business Manager and I have taken office I'm proud of the many successes, but we still have much to accomplish. None of this would be possible without the hard work and dedication from all your officers. Thank you to each of you!

What I am most proud of is that the solidarity of 638 is returning. Our solidarity has for generations held us a class above all other unions and has been our strength. We bent, but we did not break brothers and sisters! To every member who has stood up at a meeting or has come up to me personally to thank us for the hard work of all the officers, thank you. Your encouragement and sincere gratefulness is fueling us. We know that we are on the right path.

To the many members that attend a town meeting, a rally, or the many alumni events, keep up the participation. That is what keeps us strong and united as 638. To any young member who wants to participate but doesn't have anyone to go with, come, you will be greeted with smiles and open arms I guarantee it.

Local 638 just recently marched in The National Puerto Rican Day Parade. I showed up to what I thought was a parade, but ended up at a party with 1 million people. Thank you to the Parade Chairman Mike Koebel and cochairs Vinny Gaynor and Charlie Pelligrino and the many members who were instrumental in making this a huge success.

We also have the Labor Day Parade coming up this September. Business Agent Vinny Gaynor is the Chairman. As always with the help and participation of the members this parade will be another huge success.

Other good news is that man hours for our main CBA are up just under 3%, and the residential work up 79% for the first 6 months of 2024. Also the apprentice unemployment situation has significantly improved, we have had less than 10 unemployed apprentices for the last two months. Additionally the SUNY PLA bill that got passed in Albany was a huge win. We had overwhelming support in the NYS Assembly and the NYS Senate, but our biggest obstacle to the bill was Gov. Hochul. It took way too much arm bending to get her to agree to sign the bill. She is the reason there is a \$10 Million threshold rather than the \$3 million the BCTC negotiated for. It's hard to understand why any Governor who claims to be pro-union would ask for such a high threshold before a PLA takes effect? For far too long we have had out -of- state contractors with an out of state workforce come to N.Y. and perform work on SUNY campuses paid for by N.Y. taxpayers. All of this many times, at less than prevailing wage. This is unacceptable and Gov. Hochul has been put on notice! She is losing support of the BCTC. It's not a coincidence she stopped the congestion pricing which was set to go into effect in June.

Something that has come up at Trustee Meetings concerns our retired members. Members and their families have been talked into cancelling their supplemental Anthem BC/BS coverage by nursing homes or other insurance providers thinking they would save money or be eligible for other services. Please before making any decisions concerning your healthcare coverage call your Fund Office first! I can assure you no one has your best interest at heart more than your Union and the staff of the Fund Office. Another issue worth mentioning is the process of freezing your benefits. If you

have any major medical issue, whether at work or in your personal life, that might prevent you from working for an extended period of time you should call the Fund Office and request to freeze your benefits. They will send you an application which must be filled out and returned within 30 days. It can be done by you or a surrogate in the case you are incapacitated. This will keep your benefits intact for up to two years.

We are looking forward to the 2024 apprentice recruitment process which has begun. It's always an exciting time for Local 638 as we continue to build towards our future. I want to thank the Training Center for their leadership and hard work during this process. I would also like to thank Director of Training Steve Cuadra on his upcoming retirement next month. You have served Local 638 well Steve. You have far and away given more than you have taken from Local 638. Enjoy your retirement Brother you have earned it! Congratulations to our new Director of Training Danny Knights. When Local 638 needed a new director Danny had already put himself in position to have all the needed training, leadership skills and work ethic to fill that void. These two brothers are a perfect example of why 638 continues to be an industry leader and a fellowship for 140 years. The current members preparing the next generation and the next generation being prepared when the need arises. Steve had even handed over his office to Danny when the decision was made. A noble, generous and selfless act of our great Solidarity. Great job and congratulations to both.

I would like to wish everyone a happy, healthy, enjoyable summer.

IMPORTANT: SST RENEWAL INFORMATION

Site Safety Training Cards must be renewed every 5 years **<u>BEFORE</u>** the expiration date. Per NYC Department of Buildings, <u>there is NO GRACE PERIOD</u>. You must complete the refresher courses, apply, and obtain your renewed card BEFORE your old card expires. If you do not have the new card in hand the day your old card expires, you will have to complete all 40 (worker) or 62 (supervisor) hours of training again.
